5. Applewood Community Tennis Club (Ward 3)

Corporate Report dated March 24, 2008 from the Commissioner of Community Services with respect to the Applewood Community Tennis Club.

Councillor Prentice advised that she is in favour of incorporation of the Applewood Tennis Club. She provided a brief history about the incorporation of tennis clubs in relation to the Applewood Tennis Club situation. Councillor Prentice noted that she has met on several occasions with the executive of the Applewood Tennis Club and advised that they are not in favour of incorporation. She enquired about the incorporation status of the Lyndwood Tennis Club.

Ms. Pat Craigmile, Sports Manager, advised that staff are currently discussing incorporation with the Lyndwood Tennis Club. Ms. Craigmile advised that staff have had several meetings with both the Lyndwood Tennis Club and Applewood Tennis Club;

however, neither tennis club has expressed an interest in becoming incorporated at this time.

Councillor Corbasson commented that all other tennis clubs in Mississauga have incorporated. She enquired about the rationale of Lyndwood Tennis Club not pursuing incorporation and asked staff why the Lyndwood Tennis Club was not included in the Corporate Report. Councillor Corbasson suggested that the report and recommendation should have included both tennis clubs.

Ms. Craigmile advised that although the Lyndwood Tennis Club is reluctant to incorporate, there has been dialogue. She further advised that the Lyndwood Tennis Club will hold their annual general meeting on Saturday April 18, 2008 and that incorporation will be discussed at that meeting. If the Lyndwood Tennis Club decides not to incorporate then both the Lyndwood and the Applewood Tennis Clubs could be dealt with at the same time. Councillor Corbasson suggested that the report be referred back to staff to give the Lyndwood Tennis Club an opportunity to consider this matter at their annual general meeting.

Councillor Maja Prentice referred the matter in the subject Corporate Report to staff and recommended that a report be brought back to Committee on the incorporation of both the Applewood Tennis Club and the Lynwood Tennis Club. The motion was voted on and carried.

Councillor Pat Saito requested an update on recent discussions with universities and colleges, regarding the establishment of satellite campuses in Mississauga, noting that Council has not been apprised of any subsequent developments. Ms. Janice Baker, City Manager advised that there have been some discussions with the University of Waterloo, through the Economic Development Office, however there have not been any further developments. Ms. Baker advised that Sheridan College has also expressed an interest in the City of Mississauga and the City continues to work closely with these institutions, and will apprise Council of any further development. Ms. Baker noted several cities that have offered incentives to educational institutions to locate in their community, most notably the City of Kitchener.

Councillor Prentice advised that Sheridan College has relocated some of their administrative staff to the Living Arts Centre and commented that the two groups will benefit from the arrangement. Councillor Parrish expressed concern that some educational institutions may consider locating within the City Centre and requested that Council be advised of any future discussions held with education institutions, and the potential for satellite offices within the City.
