<u>UNFINISHED BUSINESS</u>

1. <u>City of Vaughan's Task Force on Democratic Participation and Renewal (Elections)</u>

Correspondence from the City of Vaughan dated November 30, 2009 with respect to issues relating to municipal elections. This matter was referred from the January 20, 2010 Council meeting to General Committee for further discussion.

Committee members enquired about the recommendations pertaining to increasing voter turnout and tax rebates for contributions to municipal campaigns. Discussion ensued with respect to the appropriateness of discussions regarding tax rebates during the election campaign period. Crystal Greer, City Clerk responded to questions regarding internet voting, number of advance polling locations, elections advertising and election cards.

Recommendation

That the correspondence from the City of Vaughan dated November 30, 2009 with respect to issues relating to municipal elections be received.

2. <u>City of Mississauga Accessibility Plan: 2009 Annual Report and 2010 Initiatives</u>

Corporate Report dated January 19, 2010 from the Commissioner of Corporate Services and Treasurer with respect to the City of Mississauga Accessibility Plan: 2009 Annual Report and 2010 Initiatives.

Recommendation

3. <u>Mississauga Bus Rapid Transit (BRT) Project Update</u>

Corporate Report dated January 26, 2010 from the Commissioner of Transportation & Works providing an update on the Mississauga Bus Rapid Transit (BRT) Project.

Councillor Frank Dale raised concerns about the availability of GO station parking lots in the City Centre area and suggested that staff review monitoring the lot to ensure it is being used by GO Transit users. Martin Powell, Commissioner of Transportation & Works noted that there are plans within the BRT Project for additional parking lots. Mayor Hazel McCallion advised that the Province of Ontario has confirmed that the land needed for the BRT Project would be at no cost. She further advised that staff would review the financial impact on the City towards acquisition of the land.

Councillor Dale expressed concern about construction work scheduled for Rathburn Road and Burnhamthorpe Road during the same time period and suggested that staff communicate to the community early about the work. Mr. Powell advised that he would meet with Councillor Dale to review the work schedule with him.

Recommendation

That the Corporate Report dated January 26, 2010 from the Commissioner of Transportation and Works entitled, "Mississauga Bus Rapid Transit (BRT) Project Update" be received for information.

4. Access to and Acceptable Use of Information Technology Policy and Supporting Guidelines

Corporate Report dated January 14, 2010 from the Commissioner of Corporate Services and Treasurer proposing an Access to and Acceptable Use of Information Technology Policy and Supporting Guidelines.

Ursula. Keuper-Bennett, Resident appeared before Committee to express her concerns about the mandate of the proposed policy and request that Committee not approve the new policy. She noted that the proposed policy would be a breach of privacy and would have no oversight by Mississauga residents.

Janice Baker, City Manager objected to comments made by Ms. Keuper-Bennett in her deputation. Ms. Baker advised that the City is obligated to appropriately watch over devices paid for by taxpayers to ensure equipment is utilized appropriately.

Members of Committee enquired of staff about the type of monitoring and scanning equipment that the City currently utilizes. Jack Lawrence, Director of Information Technology responded to questions and explained how it is used. Committee further discussed the proposed policy and noted that they had concerns with the proposal.

Recommendation

1. That the deputation made by Ursula Keuper Bennett, resident to General Committee at its meeting on February 3, 2010 with respect to the proposed Access to and Acceptable Use of Information Technology Policy and Supporting Guidelines be received.

2. That the recommendations contained in the Corporate Report dated January 14, 2010 from the Commissioner of Corporate Services and Treasurer with respect to the proposed Access to and Acceptable Use of Information Technology Policy and Supporting Guidelines be deferred pending an educational session.

5. 2010 Post Top Street Lighting Replacement Program (Wards 3 and 9)

Corporate Report dated January 7, 2010 from the Commissioner of Transportation and Works regarding the 2010 Post Top Street Lighting Replacement Program.

Eric Menezes, Streetlighting Coordinator advised that there would be no changes to the actual infrastructure but only to the headlamp. Councillor Pat Saito noted that it was her hope that the program would be expanded. Martin Powell, Commissioner of Transportation & Works advised that there would be issues with an increase in operating costs as more spares would be required, increasing the stocking charges. Mayor Hazel McCallion commented that staff should review implementing a consistent street lighting plan.

Recommendation:

That the proposed 2010 Post Top Street Lighting Replacement Program, as outlined in the Corporate Report dated January 7, 2010, from the Commissioner of Transportation and Works, be approved.
