2. That the Province be commended for introducing new broad powers to all municipalities and for recognizing that municipalities are responsible levels of government.
3. That in recognition of the fact that all municipalities are responsible and accountable governments, the spheres in two-tier jurisdictions be deleted and replaced with the same broad authority given to single-tier municipalities in all areas, and subject to the conflict rules that apply to the broad authority generally in two-tier jurisdictions.
4. That Bill 130 be amended to delete sections 239.1 and 239.2. In the alternative, that these provisions be amended to restrict the ability to request investigations to persons who are resident or own property within the affected municipality and to provide a mechanism for the investigator or the Ombudsman to dismiss requests deemed frivolous or vexatious without the need for a complete investigation.
5. That Bill 130 be amended to enable the Minister of Municipal Affairs and Housing to make regulations exempting municipalities from any of the Public Sector Accounting Board of the Canadian Institute of Chartered Accountants (PSAB) requirements, as set out in section 294.1, and that such a regulation be filed exempting municipalities from having to comply with PSAB Standard 3150 (Tangible Capital Asset reporting).

15. **INQUIRIES**

(a) Lighted School Signs (Ward 2)

Councillor Pat Mullin advised that there is a lighted sign in front of Sheridan Park Public School advertising events at the school. She enquired as to what approvals are required from the City or the School Board for lit signs advising that she had received complaints from residents living across from the school that the sign shines into the windows of their homes. The Commissioner of Transportation and Works advised that he would investigate this issue and report back to the Councillor.

(b) Election Signs

Councillor Maja Prentice advised that she had received enquiries from residents as to the reason why election signs cannot be installed on noise attenuation walls when these noise walls had been installed on private property. Councillor Pat Saito advised that the Sign By-law prevents election signs from being installed on City property only; advising that there is no restriction for the placement of election signs on private property if the owner of the property is in agreement. Councillor Prentice requested that staff advise her in writing as to the requirements under the City's Sign By-law regarding election signs.

Mayor McCallion advised that she had received complaints from residents that election signs are being installed on their property without their permission. She advised that she had suggested that the resident contact the candidate if they want the sign removed. The Mayor expressed concern that there are insufficient staffs assigned to collect election signs for the entire city. The City Manager advised that additional staff would be assigned to enforce the Sign By-law. The Commissioner of Planning and Building confirmed that his department is hiring individuals and additional trucks to enforce the Sign By-law. He also advised that the election candidates' package clearly defines the restrictions for election signs under the Sign By-law. Mayor McCallion suggested that an inventory of election signs collected by City staff should be taken.

Councillor Frank Dale requested clarification as to the installation of election signs on City park fences advising that often the fence is on private property. The Commissioner of Planning and Building advised that each location could vary and suggested that Councillors contact Zoning staff for clarification as to the placement of election signs. Councillor Saito advised that a sticker is placed on her larger election signs to identify if the fence belongs to the owner at a specific address and that permission had been granted to post this sign. She advised that this also assists in stopping the installation of illegal signs on private fences.

With respect to portable signs on roadways, Councillor Katie Mahoney enquired if the Sign By-law requires that all lettering be set behind protective glass or plastic advising that on many of these signs the original message is tampered with. She suggested that this should be considered as a requirement under the Sign By-law.
