#### MATTERS TO BE CONSIDERED

1. <u>Mississauga Cycling Master Plan and Implementation Strategy Update</u>

Corporate Report dated March 9, 2010 from the Commissioner of Community Services with respect to the Mississauga Cycling Master Plan and Implementation Strategy Update.

Ms. Piette and Ms. Alexander appeared before Committee to introduce the draft of the Mississauga Cycling Master Plan and Implementation Strategy. Ms. Piette discussed the contribution from the Mississauga Cycling Advisory Committee (MCAC) and City Staff to develop the draft Plan, and the timeline for the final report to Council.

Anne Farrell, Team Lead and Jacqueline Hunter, Traffic Operations Technician noted that the Plan was developed through consultations with the MCAC, public surveys and workshops. Ms. Farrell further noted the key messages, vision and goals of the Plan.

Mr. Wachman and Mr. Laferriere appeared before Committee to advise that the MCAC was in support of the Cycling Master Plan.

Discussion ensued with respect to the implementation plan, current cycling network and connectivity.

The following motion was voted on and carried:

#### Recommendation:

- 1. That the report dated March 9, 2010 from the Commissioner of Community Services entitled "Mississauga Cycling Master Plan and Implementation Strategy Update" be received for information;
- 2. That the Draft Mississauga Cycling Master Plan (under separate cover) be referred to a public information meeting and to stakeholders for comment.
- 3. WHEREAS the draft Mississauga Cycling Master Plan has been presented to General Committee with a recommendation to proceed with public consideration prior to final approval;

AND WHEREAS representatives from the Mississauga Cycling Advisory Committee have been involved in the review of the plan and are generally satisfied with the content of Vol. 1;

AND WHEREAS the final Master Plan along with an Implementation Plan (Vol. 2) will be presented to Council for final consideration in June 2010;

AND WHEREAS the Master Plan outlines a 20 year timeline to complete the cycling network;

AND WHEREAS the members of the Mississauga Cycling Advisory Committee feel there is urgency for cycling safety, connectivity and demand to have a functioning cycling network completed within 10 years.

AND WHEREAS there needs to be consideration for the financial and staffing implication to meet the cycling masterplan implementation targets.

#### NOW THEREFORE IT BE RESOLVED THAT:

The appropriate staff be directed to bring forward within the Implementation Plan (Vol. 2) for the Cycling Master Plan the following additional options for Council's consideration to accelerate the timing of cycling route completion and all associated financial, road rehabilitation and staffing impacts:

a) Option 1 – That all "Primary" cycling commuter network routes (on road and off road) be completed within 5 years and the remainder of the routes within a 10 year timeline.

- b) Option 2 That all "Primary" cycling commuter network routes (on road and off road) be completed within 10 years and the remainder of the routes within a 15 year timeline.
- 4. That correspondence from Arnela Radaslic and Deanna Knight, Glenforest Secondary School be received.
