### MATTERS TO BE CONSIDERED

1. <u>An Action Plan for Innovation in Mississauga</u>

Corporate Report dated September 30, 2011 from the City Manager and Chief Administrative Officer regarding an Action Plan for Innovation in Mississauga.

Mr. Petovello advised that the City's Economic Development Office partnered with the Research Innovation Commercialization Centre (RIC Centre) and the Ontario Ministry of Research and Innovation (MRI) to create an Action Plan for Innovation in Mississauga. John Switzer, Chair, RIC Centre spoke to the importance of the study and thanked the City for their support for the program. David Wolfe, University of Toronto at Mississauga spoke to the priority actions in the action plan and the need for a Mississauga Innovation Leadership Alliance' to be in place to drive the innovation agenda. Mr. Krull spoke to the action plan and noted that the City is in a good position to capitalize on the innovation plan.

Members of committee spoke to the matter and noted that it is good that the RIC Centre has identified the needs and can work with the community. The linkages with the educational post secondary institutes in the action plan and working with business and community leaders will help attract more international businesses and build more Canadian businesses.

### 2. Charity Bingo and Gaming Revitalization Initiative

Corporate Report dated September 26, 2011 from the Commissioner of Transportation and Works with respect to the Charity Bingo and Gaming Revitalization Initiative.

Mr. Wisternoff appeared before committee to ask that the City support the Charity Bingo and Gaming Revitalization Initiative. He explained the initiative and noted that it would help the currently declining revenue stream going to charities. Mr. Wisternoff advised that the OLG would operate on a cost recovery basis and that it is focused on maximum revenues back to charities. He further advised that the plan is to offer new equipments such as electronic games to attract new and lapse players.

Mayor Hazel McCallion spoke to the matter and enquired about the pilot cities for the initiative. Mr. Wisternoff provided responses with respect to the pilots in Barrie, Peterborough, Windsor, Sudbury and Kingston and noted that the OLG would be committed to adding more product lines with the current initiative. Councillors Ron Starr, George Carlson and Pat Saito spoke to the matter and noted support for the initiative. Discussion ensued with respect to the OLG financial model.

Mr. Howard, Ms. Cassidy, Mr. Crawford, Ms. Liparoti and Mr. Kahro appeared before General Committee to speak in support of the initiative. Discussion ensued with respect to the OLG financial model. Martin Powell, Commissioner, Transportation and Works spoke to the matter and noted that a change to staffing roles would be required. Councillor Jim Tovey requested that the report regarding this matter include the financials of the impact on changing the roles of staff.

## RECOMMENDATION

- 1. That staff be directed to move forward with finalizing a contractual agreement between the City of Mississauga and the Ontario Lottery and Gaming Corporation for the "Charity Bingo and Gaming Revitalization Initiative" and report back to Council with a final report.

Mayor Hazel McCallion spoke to the matter and noted that she received complaints from people that wanted to participate in both events. She further noted that she hopes that MCAC can find a way for people to contribute to the Terry Fox Run and participate in the Tour de Mississauga. Councillors Jim Tovey and Nando Iannicca spoke to the matter and noted the success of the Tour de Mississauga.
